2. **Declaration of Interest:** None
3. **Bank Reconciliations**  
**Resolved** – that the Bank Reconciliations for December 2004 and January 2005 be accepted as a true record.
4. **Mats for Martial Arts Academy**  
**Resolved** – that the Martial Arts Academy be allowed to purchase the mats from the Parish Council at a fee of £300 which is to be paid by 18<sup>th</sup> March 2005.
5. **Donation from Asda.**  
The Clerk was asked to:
  - a. Write to Asda, Donnington Wood regarding the matter of trolleys being found abandoned around the Parish.
  - b. Check the legality of offering the Parish Council's services to aid in the collection of these trolleys and, if able to do so, then the Clerk was asked to negotiate a price per trolley for their return. The trolleys would be collected by the Estate Manager as and when his availability allowed providing that help is given and that the Estate Manager is at no time exposed to the possibility of injury.
  - c. Write to Asda regarding the litter around their store requesting the possibility of litter picks occurring more frequently.
